

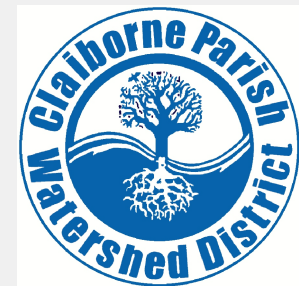
Lake Claiborne Tour 2007

Suggestions from an August, 2007 Lake Claiborne Aquatic Weeds Meeting:

1. Current Problem [confined to a few Lisbon Landing-area residences; mostly water hyacinth, which is resistant to herbicides]
 - Affected residents have been invited by mail to participate in a hand weed removal drive on Sept. 29 (Lake Clean-Up Day)
2. Long term Prevention Program [primarily against invasion of Lake Claiborne by Hydrilla and Giant Salvinia, which are causing costly damage to neighboring lakes]
 - Measures to prevent unclean boats and boat trailers from importing these plants. Consider ordinance and enforcement.
 - Consider hiring a ranger, who will regularly inspect the lake for serious invaders, report to Wildlife & Fisheries, and hand remove the weeds when appropriate.

Update 2010: Giant Salvinia was first spotted on Lake Claiborne early in 2009 in the Lisbon Landing area. Wildlife and Fisheries are working to contain it. The Watershed

District is considering routine plant and channel markers surveillance.

Eye Sores

Litter was Uncommon. Residents who take pride in the lake often pitch in and remove litter when they see it. There is litter to remove on Lake Clean-Up Day, particularly at public landings.

Suggestions

1. Lisbon Landing received repairs in 2004.
2. Arizona Landing. The process for applying for a Wallop-Breaux grant to fund repairs has been initiated. A grant will be submitted after the Permanent Markers grant has been decided.
3. Trash Cans and Regular Waste Management at the landings and the Spillway Road.

Update 2010: Arizona Landing pier repair was completed in 2008, and Piling markers were driven starting January, 2010.
